Being all of Lot 1 of John Doe Subdivision, as shown on a plat duly recorded in the office of the Register of Deeds for Buncombe County, North Carolina, in plat book 1, at page 1, reference to which is hereby made for a more particular Description.

The above-noted easement shall be a permanent easement described as:

Beginning in the Southwest corner of common property line of Doe and Smith, a 20 foot width strip running thence North along said property line of Doe parallel with improved road known as Any Street to a point 345.4 feet from said beginning point, as delineated within "Exhibit A" attached hereto.

Grantor agrees that no buildings or other structures will be placed over said easement or within such proximity thereto as to interfere with or, in the opinion of Grantee, threaten to interfere with the construction, operation or maintenance of said public utility in this easement. Temporary nonuse of limited use of this easement by Grantee shall not prevent Grantee from later making use of the easement to the full extent herein authorized.

The premises so disturbed by reason of the exercise of any of the foregoing powers, shall be reasonably restored to its original condition by the grantee.

It is understoood by the grantor that the easement(s) delineated herein may be temporarily assigned by the grantee to any other Municipal or County Agency for construction purposes.

This easement shall run with the land and be binding upon the heirs, executors, administrators, successors and assigns of the undersigned, as the holders of the legal title to the lands and premises above described.
